Position:MDS Coordinator/Charge Nurse (RN)Division:Mercy Home, Eagle LakeType:Full Time

Northern Maine General's Mercy Home is seeking a dedicated Registered Nurse (RN) to conduct and coordinate the development and completion of the resident assessment (MDS+) in accordance with current long term care rules, regulations, and guidelines. This person works as a team member in admitting, maintaining and updating care plans, and discharging residents from the long term care facility. Will work 1-2 shifts as RN Charge Nurse on the floor, providing staff supervision and direct care and treatments to residents. Maine state license as a RN and a nursing degree from an accredited college or university are required.

Northern Maine General has an opening for a full time Program Manager who will serve as the administrative supervisor of its Case Management and Behavioral Health Home staff in Aroostook County. The Program Manager assists with managing personnel duties and monitoring the provision of appropriate case management and health home services to each consumer. The Program Manager oversees hiring, orientation, assignment of cases, monitors and evaluates schedules and training requirements of staff, and provides quality assurance record reviews to ensure quality and accurate services are being provided to consumers. The Program Manager must be able to work independently, collaboratively in a team-oriented environment, and in the community. The Program Manager must also have a strong level of professionalism and leadership skills, and the ability to communicate clearly and effectively.

The desired candidate shall be at least 21 years of age, possess a bachelor's degree with a concentration in human or social services, and have had at least four (4) years of relevant experience in the intellectual disability and autism field. Candidate must also be a full MRHT-C or be eligible for a MHRT-C. Candidate must have experience supervising staff providing services to persons with intellectual disability and/or autism. A LSW with a Master's degree who is eligible for examination, or a LCSW is preferred, but not required. Valid driver's license and ability to travel throughout Aroostook County is required.

The desired candidate would provide treatment according to the child's written support plan and attend team meetings to discuss the child's progress. Flexible schedule is perfect for college student. Northern Maine General is looking for a Peer Support Specialist to serve clients in Central and Northern Aroostook County. The Peer Support Specialist uses their own unique, life-altering experience in order to guide, support, and interact with others who are in some form of recovery. This typically refers to clients recovering from mental health disorders. Peer Support Specialists identify strategies to assist the client in accessing resources and support. They monitor and supervise the client's behavior and participation in the treatment program, and they consult with the Program Manager to assure the safety of the clients and program.

Candidate must have the ability to obtain a Peer Support Specialist certification and have personal experience with mental health relevant to the services being provided, is in recovery, and is willing to self-identify on this basis with Behavioral Health Home members. The candidate must have the ability to understand and relate positively to high need clients along with a demonstrated ability to write in a clear, concise manner. Candidate must also be able to communicate well with individuals and small groups.

Northern Maine General is seeking a motivated individual to work as a Swim Instructor at the NMG Wellness Center in Eagle Lake. The Swim Instructor creates a safe, non-threatening environment while teaching swimming lessons in an indoor pool to small groups and/or one-on-one with individuals. This position has flexible hours. Instructor works as needed and when available for private lessons throughout the year. In addition, instructor works a more consistent schedule for two afternoons per week for six weeks during summer months.
